Binding Open Season

Spire Storage West LLC (Spire Storage), a natural gas storage facility owned by Spire Inc., is offering up to 6 Bcf of firm working gas storage capacity beginning April 01, 2024. Minimum contract term for firm storage service bids is 3 years. Awards are subject to a final negotiated Firm Storage Service agreement between Spire Storage and customer where Spire Storage retains sole discretion to determine the awarded capacity consistent with the terms and conditions of its FERC gas tariff.

Spire Storage is directly interconnected with five interstate pipelines including Kern River, Ruby, Northwest, Questar and Overthrust.

Spire Storage's facilities are located in Uinta County, Wyoming approximately 60 miles southwest of the highly liquid Opal Hub. Spire Storage is uniquely positioned to serve multiple regions and customers – utilities, power generators, marketers and pipelines.

See the attached documents for the Bid Response Form containing specific terms for fuel, variable fees, receipt/delivery points available and injection/withdrawal ratchets. Bids including those with injection and withdrawal ratchets will be given priority consideration.
