Dear Secretary Bose:

Pursuant to Order No. 587-Y, the Commission's Final Rule in Docket No. RM96-1-041,¹ and Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations,² Bluewater Gas Storage, LLC ("Bluewater") hereby submits for filing as part of its FERC Gas Tariff, First Revised Volume No. 1 ("Tariff"), the following revised tariff sheets:

Section 6.23 – North American Energy Standards Board, Version 10.0.0

Bluewater respectfully requests that the specified tariff sheets be accepted effective August 1, 2019, consistent with the compliance deadline requirement in Order No. 587-Y.

Statement of Nature, Reasons and Basis for Proposed Modifications:

In Order No. 587-Y, issued on November 15, 2018, the Commission adopted changes to its regulations to incorporate Version 3.1 of the North American Energy Standard Board ("NAESB") Wholesale Gas Quadrant ("WGQ") Standards in Order No. 587-Y. Specifically, the Commission adopted revised standards governing the business practices and communication methodologies of interstate natural gas pipelines, in place of the currently incorporated version (Version 3.0) of those same business practice standards.

Pursuant to Order No. 587-Y, jurisdictional pipelines and storage companies are required to make a compliance filing by April 1, 2019 to be effective August 1, 2019. The purpose of this present filing is to comply with the Commission's Order No. 587-Y. In compliance with Order No. 587-Y, Bluewater is submitting separate tariff records reflecting the changed standards to take effect on August 1, 2019. Bluewater's attached tariff records reflect all of the current NAESB Standards to date and specify whether such standard is incorporated by reference or included in a specific tariff provision (and if the latter, then where such tariff provision is located), as well as indicate which standards Bluewater has received, or is seeking, a waiver or extension of time, or other variance with respect to compliance with the standard. Upon implementation of the tariff modifications described above, Bluewater will have fully complied with Order No. 587-Y.

Request for Continuation of an Existing Waiver or Extension of Time:

The Commission has previously granted Bluewater an extension of time to implement certain NAESB Standards, including NAESB Standards related to the EDI/EDM and FF/EDM communication standards until 90 days following a request that it provide such communications.³ More recently, the Commission granted Bluewater a similar request for an extension of time to implement Electronic Data Interchange ("EDI") and Electric Delivery Mechanism ("EDM") requirements, as well as the Internet Electronic Transport ("IET") requirements, in response to the Commission's Order No. 587-V and Order No. 587-W.⁴ Bluewater continues to operate on the same basis that the Commission relied on when it previously granted extensions for compliance with these standards. That is, Bluewater has not received a request for EDI/EDM and FF/EDM communications and does not anticipate that it will receive such a request in the foreseeable future. In accordance with the requirements of Order No. 587-Y, Bluewater respectfully requests continuation of these extensions of time for Version 3.1 of NAESB's Standards, including its most recent EDM requirement under Standard 4.3.106, for the reasons stated above.⁵

In accordance with Order No. 587-Y, Bluewater is providing the following table, which identifies the latest docket wherein the waiver or extension of time was granted.

BLUEWATER has adopted the Business Practices and Electronic Communications Standards, NAESB WGQ Version 3.10, and the standards revised by Minor Corrections MC15003, MC15004, MC15005, MC15009 and MC15012 all marked with an asterisk [*], which are required by the Commission in 18 C.F.R. Section 284.12(a), as indicated below. Standards without accompanying identification or notations are incorporated by reference. Standards that are not incorporated by reference are identified along with the tariff record in which they are located. Standards for which waivers or extensions of time have been granted are also identified.
