

Solicitation of Offers to Purchase Natural Gas

March 28, 2024

Cameron Interstate Pipeline LLC (“CIP”) is soliciting offers to purchase from CIP up to 210,000 MMBtu (“Total Contract Quantity”) of natural gas during the month of April 2024 (“Contract Period”). It is anticipated that the Contract Period will extend from approximately the Gas Day for April 2, 2024, through the Gas Day for April 22, 2024.

Pertinent details applicable to those wishing to participate in this solicitation (“Participants”) are as follows:

The point of delivery for such gas shall be CIP’s interconnection with LA Storage LLC (CIP Location Number 772295 in Ragley, Louisiana (“Delivery Point”).

The Participant that is selected to purchase gas under an executed NAESB Base Contract for Sale and Purchase of Natural Gas, as described below (“Purchaser”), shall be responsible for arranging and paying for all transportation, including all applicable surcharges and fuel, away from the Delivery Point.

Offer Price should be stated based off the Tx. Eastern, WLA index as published in the Platts Gas Daily for the respective flow date.

No partial quantity bids (*i.e.*, less than 210,000 MMBtu over the course of the Contract Period) will be considered. Potential purchasers must be willing to purchase up to the entire Total Contract Quantity.

The sale will be made to Purchaser on a firm basis. The Purchaser will receive the volume over the Contract Period.

Participants interested in submitting offers to purchase the natural gas pursuant to this posting must have in place or must be willing to negotiate and execute a NAESB Base Contract for Sale and Purchase of Natural Gas, a form of which is available from CIP upon request. Participants must also be pre-approved as meeting the creditworthiness requirements as established by CIP’s credit department. Parties interested in submitting offers for the purchase of natural gas pursuant to this posting should email a completed Offer Form (attached to this solicitation) to Shawna Sallee at ssallee@sempraglobal.com no later than **3:00 PM (CCT) on March 29, 2024**. Only those offers received by CIP on or before this deadline will be considered.

Purchaser(s) shall be selected based upon the highest-priced offer(s). In the case of ties, CIP will allocate sales quantities to winning offers on a pro rata basis. Winning Purchaser(s) will be notified by no later than 4:00 PM (CCT) on March 29, 2024, and must be willing and able to negotiate and execute a NAESB Base Contract for Sale and Purchase of Natural Gas on or before March 29, 2024. If a potential Purchaser is unable to meet CIP’s creditworthiness requirements or execute

an acceptable NAESB Base Contract for Sale and Purchase of Natural Gas in the timeframes specified in this posting, CIP reserves the right to award the sale of natural gas to the participant submitting the next highest offer.

CIP reserves the right to refuse any and/or all offers, if deemed unacceptable.

This Solicitation of Offers to Purchase Natural Gas does not constitute a binding offer to sell natural gas on the part of CIP. Any agreement for the purchase of natural gas shall be subject to CIP's receipt and acceptance of offers submitted pursuant to this solicitation and execution of a NAESB Base Contract for the Sale and Purchase of Natural Gas.
