# **Bidding Requirements:**

Prospective bidders interested in participating in this Open Season are invited to return the completed bid form ("Open Season Binding Bid Form") contained herein, which must be filled out completely for the bid to be considered conforming, to ECGS@tallgrass.com prior to the close of the Open Season.

East Cheyenne will consider bids for a portion of the quantity listed above. Conforming bids must be at or below the Maximum Price stated in the Operational Purchase Terms stated above.

#### **Bid Evaluation:**

East Cheyenne will evaluate bids in the Open Season based on the bidder's price per Dth. Purchases will be made beginning with the lowest price per Dth until all gas has been purchased. East Cheyenne reserves the right to purchase less than the full quantity of gas bid by a bidder in the event the bid exceeds the offered Gas Quantity or lower priced gas has already been purchased and the entire bid amount is not required; provided however, East Cheyenne will not award a prospective bidder less than its identified minimum Gas Quantity.

In the event there are two or more bids with an equal price, the purchase will be allocated pro rata to the extent necessary.

East Cheyenne may, in its sole discretion and in a not unduly discriminatory manner, consider bids that are non-conforming bids; provided however, East Cheyenne is under no obligation to accept non-conforming bids and non-conforming bids will not be considered until all conforming bids are evaluated and awarded.

East Cheyenne reserves the right, in a non-discriminatory manner, to: (1) withdraw its posting (2) reject all bids due to operational changes; and (3) reject any bids which are not complete, which contain modifications to the terms and conditions of the posting, or which contain terms that are operationally unacceptable.

# **Additional Obligations:**

By submitting a bid in this Open Season, each bidder agrees it will execute a NAESB reflecting the Operational Purchase Terms of the bidder's award.

## **East Cheyenne Reservations:**

The gas quantity solicited for purchase in this open season reflects East Cheyenne's expectations, at the time of posting, and of system operating conditions for the applicable period. East Cheyenne reserves the right to purchase less gas based on system conditions at the time of award.
