Pursuant to Section 4 of the Natural Gas Act¹ and Part 154 of the regulations of the Federal Energy Regulatory Commission (the “Commission”) promulgated thereunder,² Sabine Pipe Line LLC (“Sabine”) hereby submits for filing as part of its FERC Gas Tariff, First Revised Volume No. 1 (“Tariff”), the following Tariff record proposed to become effective on June 1, 2022, as more fully described in this filing: Section 7.23, Version 5.0.0.

STATEMENT OF NATURE, REASONS AND BASIS

On July 15, 2021, in Docket No. RM96-1-042, the Commission issued Order No. 587-Z (the “Order”) amending Section 284.12 of its open access regulations, 18 C.F.R. § 284.12, governing standards for conducting business practices and electronic communications with interstate natural gas pipelines.³ Specifically, the Commission adopted, with certain enumerated exceptions, the latest version (“Version 3.2”) of the consensus industry standards promulgated by the Wholesale Gas Quadrant (“WGQ”) of the North American Energy Standards Board (“NAESB”) by incorporating these standards by reference into its regulations.

The revised tariff record included herein reflects the Version 3.2 standards adopted by the Order and incorporated by reference into the Commission’s regulations. Additionally, Section 7.23 of the Tariff reflects the format of the tariff provision set forth in the Sample Tariff Record issued by the Commission on August 3, 2021.

REQUEST FOR CONTINUATION OF THE EXTENSION OF TIME TO IMPLEMENT THE EDI/EDM AND FF/EDM REQUIREMENTS

Section 284.12(b)(3) of the Commission’s regulations⁴ requires pipelines to implement Electronic Data Interchange (“EDI”) transactions. Per the table below, the

Commission has previously granted Sabine a temporary waiver of these requirements related to prior NAESB standards due to the lack of requests from parties to use EDI transactions and the substantial cost to upgrade the software if no party desires to use it:

Following receipt of the temporary waiver in 2005, Sabine received a request to implement EDI transactions for four NAESB WGQ Datasets (1.4.1, 1.4.2, 1.4.5, and 2.4.4). Sabine promptly implemented EDI transactions for the requested datasets. In compliance with the Order and as provided in the revised Tariff record submitted hereby, Sabine will implement Version 3.2 of these same datasets on June 1, 2022.

Sabine hereby respectfully requests a continued extension of time to implement EDI transactions for the following NAESB WGQ Datasets until 60 days after Sabine receives any bona fide request for the use of these EDI transactions: 0.4.1-0.4.3, 1.4.3-1.4.4, 1.4.6-1.4.7, 2.4.1-2.4.3, 2.4.5-2.4.11, 2.4.17-2.4.18, 3.4.1-3.4.4, 5.4.14-5.4.17, 5.4.20-5.4.27. To date, Sabine has not received any bona fide requests for the use of any EDI transactions related to these datasets, and Sabine submits that the cost of implementing such capability, where there is no demand, is not a prudent use of its resources.

PROPOSED EFFECTIVE DATE AND MOTION

Pursuant to Section 154.7(a)(7) of the Commission's regulations,⁵ Sabine respectfully requests a waiver of the notice requirement contained in Section 154.207 of the Commission's regulations,⁶ and any other waivers that may be required for the Commission to accept the revised tariff record filed herein to become effective as of June 1, 2022. Good cause exists to grant this waiver in order to adhere to the compliance filing deadline of November 12, 2021 as set forth in the Order.

Pursuant to Section 154.7(a)(9) of the Commission's regulations,⁷ Sabine files this motion to place the revised tariff records filed herewith into effect at the expiration of any minimal suspension period set by the Commission, provided that the tariff changes are approved as filed and without condition. In the event the tariff record filed herewith is not

approved as filed and without condition, Sabine reserves the right to file a motion at a later date to place such tariff record into effect.

COMPLIANCE WITH REGULATIONS

The filing contains (i) this transmittal letter; (ii) a clean version of the proposed Tariff record in Word format; and (iii) a marked version of the proposed Tariff record in PDF format showing additions to and deletions from the currently effective Tariff record.

Pursuant to Section 154.201(a) of the Commission's regulations,⁹ Sabine has included a clean and marked version of the proposed Tariff record reflecting the proposed changes, and pursuant to Sections 154.2(d) and 154.208(b) of the Commission's regulations,¹⁰ Sabine will send a copy of this filing by electronic mail to each of Sabine's shippers and affected state commissions. This filing is also available for public inspection during regular business hours in a convenient form and place at Sabine's offices at 1722 Routh Street, Suite 1300, Dallas, Texas 75201.

In compliance with Section 154.204(f) of the Commission's regulations,¹¹ Sabine states that it has no other Tariff filings pending before the Commission that may significantly impact this filing.
